Withdrawal Policy

A refundable deposit is payable upon the child’s commencement which shall be repaid in full after deducting any amounts due to the school, provided a written notice is served at least 4 term weeks before the child’s last day in school.

Subsidy

For children aged 18 months to 6 years, the monthly subsidies are:

- Monthly Basic Subsidy up to \$300
- Monthly Enhanced Subsidy* - up to \$467. An additional subsidy on top of the basic subsidy.

*Enhanced Subsidy: Gross monthly household income of \$12,000 and below or Per Capita Income of \$750 and below for larger families

Eligibility:

- Child must be is a Singapore Citizen enrolled in Primus Schoolhouse child care centre for Half-Day/Full-Day program
- Working OR non-working applicant - A working applicant refers to a mother or single father who works at least 56 hours per month (includes full/part-time and freelance work arrangements)
